## Corporate Tournament

The Corporate Tournament occurs Friday, August 9th at 5:30pm. A maximum of 12 corporate teams will be registered for the tournament. Fun and entertaining play-by-play will be announced for all spectators to cheer on the teams. Expect to have some of your team members interviewed for the crowd afterwards. This is a great way to promote the fun side of your business! Teams can consist of up to four people and at least 3 members of the team must work for the partner organization. Games will be 10 minutes long or played to 15, whichever comes first. Winning team will receive a photo plaque (to keep) and a traveling trophy (for 1 year). If inclement weather prohibits the tournament from taking place on Friday, we will attempt to reschedule on either Saturday or Sunday. Teams must be registered for the tournament no later than June 28th.

## Vendor Area

All partners must provide their own tables, tents and power supply. Booth materials will not be provided by the Macker Committee. Partners are not permitted to sell food or drink items. Vendors should be set up by 3:00pm on Friday.

**Partners must reserve a vendor area no later than June 28th. Day of requests will not be honored.**

## Logos, Ads and Announcements

For all new partners, please provide your logo with a transparent background within 2 weeks of submitting partner commitment form. Ads for the Gussette must be received no later than June 28th. For partners receiving daily commercials, narratives or pre-recorded announcements they will be accepted through July 19th.
